**Subject: Validation of Colombian Driver Licences**

Dear Sir/Madam,

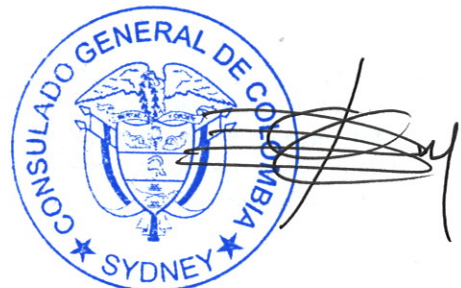
With respect to the above-mentioned subject, the Consulate General of Colombia in Sydney wishes to inform you about the appropriate documents and process to validate the status of a Colombian Driver License and the driver record of its owner.

The only official document that the Government of Colombia issues regarding the status of a Colombian Driver License is called "Informe General del Conductor" (General Driver Report) and is issued online in PDF format. This document will show the Colombian driving licenses that the person has, indicating whether their status is active (activa), expired (vencida), or inactive (inactiva). Colombian law prohibits the addition of physical stamps or signatures to this PDF document. You can validate the authenticity of an "Informe General del Conductor" (General Driver Report) through the link <https://web.mintransporte.gov.co/certificadoslc/certificados/consulta/>

Colombian citizens must present an apostille on the "Informe General del Conductor" (General Driver Report) to validate their Colombian Driver License status to a foreign authority such as yours. Colombian apostilles can only be issued online and come in PDF format. Colombian law and the 1961 Hague Convention prohibit the addition of physical stamps or signatures to this electronic document.

Colombian apostilles contain a QR code that you can use to validate their authenticity online. Colombian apostilles also provide an electronic copy of the document "Informe General del Conductor" (General Driver Report) that was used by the person to issue the corresponding apostille.
